1. CALL TO ORDER AND ROLL CALL

A motion was made and seconded to call the May 12, 2014 Outcomes Committee Meeting to order at 3:12p.m. Dr. Fredy Aviles, SLO Faculty Co-Chair, called the meeting to order at 3:05 p.m. Motion carried.

2. OPENING COMMENTS FROM THE SLO COMMITTEE CHAIR

Dr. Fredy Aviles requested the committee to announce in their next division meeting that SLO and PLO data is due and needs to be entered in Weave.

3. OPEN COMMENTS FROM THE PUBLIC

No comments from the public were made.

4. **APPROVAL OF MINUTES**

a. April 28, 2014

A motion was made and seconded to approve the minutes from the April 28, 2014 Outcomes Committee meeting. Motion carried.

5. **REPORTS**

a. Updates from the Department of Institutional Effectiveness, Research, and Planning – Dr. Meeta

Dr. Meeta Goel announced that AVC was at 100% compliance last fall and requested representatives to encourage faculty to meet the same level of entry in Weave.

A motion was made and seconded to amend the agenda to include item 6c PHTC 102L. Motion carried.

7. **DISCUSSION ITEMS**

a. Tina McDermott

Ms. Tina McDermott attended the committee meeting to address the concerns related to the Degree Qualification Profiles (DQP). She indicated that it is important to revise our ILOs to be in line with the DQP which will show the mapping from SLOs to PLOs to the ILO level. Dr. Irit Gat felt this should be done quickly but requested clarification on the appropriate body to do the revise. Ms. McDermott indicated that perhaps this committee or a taskforce created from this body would produce the revised ILOs and present them to the Senate for consideration. She indicated that the current challenge has been assessing the ILOs as written. If the ILOs could be rewritten we will be able to better assess our progress. She indicated that it was not necessary to think in term of DQP as the DQP is written into the accreditation standards. The Outcomes Committee would just need to write the ILOs according to the accreditation standards. Mrs. Adams indicated that the DQP were originally presented to the committee as a rewrite of all PLOs but it sounds like the ILOs are the only piece needing to be rewritten. Dr. Aviles added that the general education outcomes (GEOs) should also be revised. Ms. McDermott clarified that if the ILOs are rewritten it may make the revision to the PLOs unnecessary since most PLOs are already mapped to the ILOs. It was suggested that assessment occur once at the SLO level, which should map up to the PLOs and ILOs. Dr. Aviles also stated that writing of the next set of accreditation responses will be facilitated by this new process. Dr. Scott Lee asked if there is a timeline for the ILO revisions as this has been discussed since 2008 without action. It was also noted that SPBC wrote and approved the original ILOs so perhaps the outcomes committee can send the recommended revisions to that committee for consideration. Ms. McDermott indicated that the process should be doable and not cumbersome. Dr. Aviles mentioned that some colleges have rewritten their ILOs according to the new language to which the committee requested sample. Dr. Aviles agreed to present the samples at Welcome Back along with the Psychology PLOs as he had already revised the existing PSY AA-T PLOs to the DQP. Ms. McDermott suggested the revisions to the ILOs be done early fall semester and sent upwards for approval.

b. SLO committee goals (attachment)

After a review of the committee goals, it was requested that 'SLO" in the Mission be replace with "Outcomes Committee." It was also requested that the mention of OOs in goal number one, be removed as OOs will not be entered in CurricUNET. A discussion occurred regarding the issue of representation as many areas are not present at the meetings especially the OO representatives. Glenn Haller announced that Senate is currently reviewing its structure and change will likely affect the subcommittees. As a result if more or less representation is needed, a recommendation should be directed to the Senate. Ms. Melanie Parker suggested another goal be added that speaks to the revision of the ILOs. Dr. Meeta Goel asked if it would be appropriate to discuss the attendance issues with the executive council.

Dr. Fredy Aviles requested the committee members to review the Welcome Back presentation in the agenda packet and send their feedback via email. Ms. Stacey Adams expressed her concerns as Ms. Tina McDermott just spoke to the need for ILO revision but the Welcome Back presentation is suggesting a rewrite of the PLOs. Dr. Aviles will add the PLO sample as written to the DQPs and explained that the presentation is meant to be informational. Dr. Aviles indicated that he would send the finalized description and goals along with the presentation and PowerPoint.

The Outcomes Committee provides specific observable characteristics developed by faculty and staff that allow them to determine or demonstrate evidence that learning has occurred as a result of a specific course, program, activity, or process. The Antelope Valley College Board of Trustees relies primarily on the Academic Senate for advice on educational program development, standards/policies regarding student preparation and success, degree and certificate requirements, and curriculum including prerequisites; thus the Committee for Student Learning Outcomes is an Academic Senate responsibility.

The Outcomes Committee will determine a campus-wide process for the uniform implementation and assessment of Student Learning Outcomes at the course, program, and department level. A faculty chair is responsible for chairing the committee and overseeing that the functions of the Outcomes Committee are met.

Potential new mission statement:

The Outcomes Committee provides guidance on matters related to the development, assessment, and approval of student learning outcomes (SLOs), program learning outcomes (PLOs), operational outcomes (OOs), general education outcomes (GEOs), and institutional learning outcomes (ILOs). The committee sets deadlines for entering assessment data and action plans in WEAVEonline. The Outcomes Committee also sets process and procedures for ensuring the quality, accuracy, usefulness, and consistency of outcomes assessments and outcomes assessment data.

The Antelope Valley College Board of Trustees relies primarily on the Academic Senate for advice on educational program development, standards/policies regarding student preparation and success, degree and certificate requirements, and curriculum including prerequisites; thus the Committee for Student Learning Outcomes is an Academic Senate responsibility. The Outcomes Committee is co-chaired by a full-time faculty member and the Dean of the Department of Institutional Effectiveness, Research, and Planning that are jointly responsible for overseeing that the functions of the Outcomes Committee are met.
