

How To Fill Out the OSD Alternative Testing Agreement

Alternative Testing Instructor Resource

Overview of the OSD Alternative Testing Agreement

- ▶ 1. At the beginning of each semester, OSD students will request their approved testing accommodations for each class they anticipate utilizing those services.
- ▶ 2. In those instances, you will receive an email notification stating that “your student is eligible for OSD Alternative Testing services.”
- ▶ 3. The email notification will direct you to fill out an OSD Alternative Testing Agreement. In the Agreement, you will provide required information and testing instructions for proctoring each type of exam offered in your class. There are four exam types: 1) Standard Exam, 2) Midterm, 3) Final and 4) Quiz.
- ▶ 4. Only one OSD Alternative Testing Agreement is needed for each course section(CRN), no matter how many OSD students are enrolled in that particular section.
- ▶ 5. We ask that you fill out the agreement right away. This will help avoid exam scheduling delays as well as allow time in advance to work out any details in order to provide a smooth testing experience for both you and your students.

Accessing the OSD Alternative Testing Agreement

- ▶ In your email notification, simply select the “OSD Alternative Testing Agreement” link.

Your student is eligible for OSD Alternative Testing services.

OSD ALTERNATIVE TESTING AGREEMENT SUMMER '21 DESCRIPTION

Type: **2021 Summer- OSD Alternative Testing Agreement**

The purpose of this agreement is to provide Testing Center staff the direction needed to successfully proctor instructors' accommodated exams and quizzes, for your OSD Students that are taking in-Person Face-to-Face and in-Person Blended classes for Summer '21.

Note: The Testing Center will be operating with limited hours and capacity for Summer '21.

NOTE: If exams are not given in a proctored environment (such as take-home or online exams not proctored in the Testing Center), the exam/quiz proctoring agreement should **NOT** be completed.

- Instructors will only need to complete this OSD Alternative Testing Agreement once for each course section no matter how many students are accommodated for alternative testing in their class.

FACULTY / STAFF INSTRUCTION

Important information for Faculty:

Please note that the Lancaster and Palmdale testing hours are limited for the 2021 Summer semester due to COVID restrictions.

This online agreement replaces the TEST ACCOMMODATION REQUEST paper form that was in use up until Spring '20.

1. Please complete the six short questions that make up this agreement.
2. Only enter standard length of exam/quiz times for the class- **do NOT** enter extended accommodated time.
3. Your student may not be able to schedule their exam during your class time as a result of very limited Testing Center.

- ▶ Questions will include items such as exam delivery/return preferences, specific instructions for each exam type, resources allowed, computer requirements, etc.

- ▶ Note that our system will automatically calculate extended time for students that receive an accommodation for extra time.


