1. CALL TO ORDER AND ROLL CALL

A motion was made and seconded to call the September 11, 2014 AP&P Committee Meeting to order at 3:10p.m. Mrs. Linda Harmon, AP&P Faculty Co-Chair, called the meeting to order at 3:10p.m. Motion carried.

2. OPENING COMMENTS FROM THE COMMITTEE CO-CHAIR

Mrs. Linda Harmon welcomed the committee members to the first meeting of the fall semester and introduced the new VP of Academic Affairs, Dr. Bonnie Suderman.

3. APPROVAL OF MINUTES

- a. **April 24, 2014 Minutes**

A motion was made and seconded to approve the minutes for both April 24, 2014 and May 8, 2014. Motion carried without revision.

4. INFORMATIONAL ITEMS

a. 2014-15 AP&P Deadline – Courses and Programs need to be approved by 11/13/2014 for Fall 2015 inclusion

- **TMC Degrees that may need to be developed and brought to AP&P – List at the end of the agenda**
- **C-ID Approval needed, COR revised and brought to AP&P – List at the end of the agenda**

Mrs. Linda Harmon stated the courses continue to need the SLOs approved prior to the review of the COR and as a result courses need to be entered within CurricUNET quickly to ensure they are approved by the November 13, 2014 deadline. As in the past the courses requiring revision this academic year are listed at the end of the agenda.

Mrs. Harmon also reviewed the list of TMC degrees that can be adopted by the AVC listed under item 7b. Faculty should review the CCCCO program template to determine if our courses align with the program. Adopted programs should be entered and submitted within CurricUNET for AP&P review and approval. Dr. Uhazy indicated that it is not likely that AVC will be able to adopt Agriculture Animal Science or Agriculture Plant Science, however faculty are interested in Agriculture Business. He also indicated that Environmental Science is of interest when developed by C-ID.

Mrs. Harmon announced two additional TMC degrees have received the Chancellor's Office approval: Psychology and Administration of Justice. These degrees will be available for students to claim in Fall 2015 and will be listed in the next college catalog. Dr. Grishman expressed his concerns with waiting a year to make the programs available to students. He asked if it would be possible to publish an addendum to the catalog such that students could claim the degree in Spring 2015. Dr. Suderman requested clarification on the impact this would have on the Academic Affairs staff and the length of time needed to create this type of document. Mrs. Melissa Jauregui indicated that it could be done but that a format would first need to be developed as a document like this has never been created before. The first addendum would take a bit of time to create but

future addendum would be simpler as they would follow the same format. Dr. Suderman indicated that she would request clarification from the President, Mr. Knudson, on whether this is a possibility from the institutional stand point.

Mrs. Harmon also mentioned that there are many TMC degrees that require courses to be revised to align with the C-ID, which are noted under item 7d. The notices of changes would have been email by Dr. Grishman and faculty should revise the course within CurricUNET and submitted to receive local approval before the course can be submitted for C-ID approval.

Dr. Lee Grishman, Articulation Officer, announced updates to the list above. AJ 210 was not submitted for IGETC nor for CSU GE, however, it will be submitted in the next round of approvals for CSU GE. AJ 210 does not qualify for IGETC.

5. DISCUSSION

a. Significant Lapse in Time

Mrs. Linda Harmon announced this topic but indicated that this discussion item was requested by Dr. Cowell who is not in attendance. Dean LaDonna Trimble indicated that she could speak to this topic in Dr. Cowell's absence. She indicated that our current policy allows a student, who received a standard grade, to retake a course only after 5 years have passed. Title 5, on the other hand, allows a student, who received a standard grade, to repeat a course due to significant lapse in time after 36 months. The Nursing program now requires students to have a GPA not less than 2.5 and for some students, past coursework may need to be repeated in order to improve their GPA for admittance. She also indicated that repeated coursework does not impact student's college GPA as our policy is to only calculate the GPA using the first standard grade but the admittance process may look at the newer grade to determine eligibility. The committee requested clarification on the policy to only use the first standard grade when calculating GPA as this seems unfair to students. Dr. Les Uhazy indicated that the change to this policy will create additional competition in enrollment in the biology coursework required by the Nursing program. Additional discussion occurred on how this change would impact other programs as this seems specific to the Nursing program. It was stated that the change to this policy would be campus wide. The committee members were asked to consult with faculty in their area to determine if this change would negatively impact an area. It was requested that the Title 5 policy along with our Board and Administrative policy be sent to the representatives to be shared with their division faculty. Dean Trimble agreed to collect that information so it may be sent to the committee members.

b. AP&P Handbook 2014-2015

Mrs. Linda Harmon stated the handbook was revised to include the SLO information for course revisions as this process has been fully implemented. Other changes to the handbook include the requirement for AP&P

representatives to assist faculty with the use of CurricUNET by attending at least on CurricUNET workshop each semester.

AP 4228 Course Repetition – Significant Lapse of Time

Reference:

Title 5 Section 55043

Students may be permitted or required to repeat courses in which a “C” or better grade was earned where there was a significant lapse of time since the grade was obtained and:

- The District has defined “significant lapse of time” or has established a recency prerequisite for a course or program; or
- An institution of higher education to which a student wishes to transfer has established a recency requirement that the student cannot satisfy without repeating the course.

When a student needs to repeat an activity course due to a significant lapse of time, each repetition attempt will be counted toward the established repetition limits. However, if a student has already exhausted the number of permitted repetitions, then an additional repetition due to significant lapse of time may be permitted or required by the District.

When a course is repeated due to a significant lapse of time, the District may disregard the previous grade and credit when computing a student’s grade point average.

grade will be used in calculating the grade point average. **NOTE:** Students will be permitted to withdraw and receive a “W” and/or a substandard grade in a class on no more than three occasions. After two enrollments students will be required to submit an Extenuating Circumstances petition for the third and final enrollment at AVC.

Repetition of courses for which substandard work has not been recorded (grades “A,” “B,” “C” or “P”) may be permitted only upon petition by the student and with the written permission of the Dean of Enrollment Services. Grades awarded for courses repeated under the provisions of this section shall be included when calculating a student’s GPA.

Special circumstances under which a student may be allowed to repeat a course in which he/she has received a grade of “A,” “B,” “C” or “P” are as follows:

1. A period of 5 years has elapsed since the last time the student completed the class, and the student can justify the need to repeat the class as a “refresher course” prior to advancing on to the next higher level of course work.
2. The student needs to repeat the class as a “refresher class” because comprehension of the course material is directly related to success on the job.
3. When a student repeats a class, the previous grade and credit shall be disregarded in the computation of grade point average.
4. Other special circumstances as deemed appropriate by the Dean of Enrollment Services.

Repeatable Courses

(Title 5, Section 55041)

Regulations governing the repetition of credit courses have designated the following types of courses as repeatable:

- Courses for which repetition is necessary to meet the major requirements of CSU or UC for completion of a bachelor’s degree.
- Intercollegiate athletics
- Intercollegiate academic or vocational competition where enrollment in the course and courses that are related in content is limited to no more than four times for semester work. This enrollment limitation applies even if the student receives a substandard grade or “W” during one or more of

the enrollments in such a course or petitions for repetition due to special circumstances.

- Instances when such repetition is necessary for a student to meet legally mandated training requirements as a condition of continued paid or volunteer employment. (Title 5, Section 55040-55043, and 55253)
- A student may be permitted to repeat a course due to significant lapse of time. AVC designates five years as significant.
- A student may repeat a course as a result of a significant change in industry or licensure standards such that repetition is necessary for employment or licensure.

A sequence of courses may include more than four courses, but students are limited to a maximum of four enrollments in any family. Further, all grades, including “W” will count toward the four course enrollment limitation and used for computing the grade point average. These repeatable courses are identified in the catalog by the symbol (R) and a number which represents the total number of times the course can be repeated, e.g. (R3) means the course may be taken for a total of four times.

Students may request to repeat a repeatable course to have a substandard grade excluded (before the maximum allowable repeatability is completed) from the student’s GPA by submitting a Petition for Extenuating Circumstances to the Dean of Enrollment Services for consideration.

Academic Renewal

A student may petition through the Dean of Enrollment Services to have up to 30 semester units of course work taken at Antelope Valley College eliminated from the computation of Antelope Valley College total grade point average. The approval or disapproval of the petition will take place administratively pursuant to rules stated herein and those approved by the Governing Board. A student may petition for academic renewal only once, and all units up to 30 must have been taken in consecutive semesters of attendance excluding summer sessions and intersessions. Only “D” and “F” grades may be eliminated from the computation of the GPA under the Academic Renewal Policy.

The student seeking academic renewal must present evidence that the previously

recorded work was substandard academic performance and is not reflective of more recently demonstrated academic ability.

Evidence of recent academic ability will be determined by one of the following:

- 12 semester units with at least a 3.0 GPA
- 18 semester units with at least a 2.5 GPA
- 24 semester units with at least a 2.0 GPA

Work taken in the last semester being petitioned must have been completed at least 24 months prior to the date the academic renewal petition is submitted by the student.

Petitions for Extenuating Circumstances

Petitions are formal requests for an exception to or waiver of college procedures (refunds, grade changes, grade removals, etc.) Extenuating circumstances are verified cases of accidents, illness, family, or work obligations and other circumstances beyond the control of the student. Petitions without justifiable documentation are subject to denial and will be returned to the student.

Petitions for changes of grade are done informally with the instructor. If a satisfactory resolution does not occur, the student may appeal the grade to the Division Dean and then to the Vice President of Academic Affairs. Students have one year to appeal after the grade is awarded.

Extenuating Circumstance Petitions may be obtained from Admissions and Records. All petitions will be forwarded to the Petition Committee and/or its designee. Once a determination has been made, notification will be sent by mail or e-mail. Students wishing to appeal the decision regarding a petition should speak with the Dean of Enrollment Services.

Official Communication to Students (AP 5041)

Students are responsible for reading all official communications from Antelope Valley College (AVC). Methods of communication are students’ AVC email, United States Postal Service and printed publications, including (but not limited to), the AVC Catalog, Schedule of Classes, and Student Handbook.

§ 55043. Course Repetition Due to Significant Lapse of Time.

(a) In addition to permitting course repetition in the circumstances described in other provisions of this article, a district may also permit or require repetition of a course where the student received a satisfactory grade the last time he or she took the course but the district determines that there has been a significant lapse of time of no less than 36 months since that grade was obtained and:

(1) the district has properly established a recency prerequisite for a course or program pursuant to section 55003. or

(2) another institution of higher education to which the student seeks to transfer has established a recency requirement which the student will not be able to satisfy without repeating the course in question. Pursuant to petition, a district may allow repetition where less than 36 months have elapsed pursuant to this subdivision if the student documents the repetition is necessary for the student's transfer to the institution of higher education.

(b) If the district determines that a student needs to repeat an active participatory experience course, as defined in section 55000, in physical education or visual or performing arts, or an active participatory experience course that is related in content, as defined in section 55000, due to significant lapse of time, that repetition shall be counted in applying the limit on repetitions set forth in section 55040(c) except that, if the student has already exhausted the number of repetitions permitted under subdivision (c), an additional repetition due to significant lapse of time may be permitted or required by the district.

(c) When a course is repeated pursuant to this section, the district policy may allow the previous grade and credit to be disregarded in computing the student's GPA.
