Ms. Clinton called the meeting to order at 3:08 p.m. Other than taking some items out of order, the agenda will remain as presented.

2. Approval of Minutes from April 23, 2009

The minutes were distributed. Due to time constraints, the minutes will be discussed and approved at the next meeting.

- 3. SLOs to be included either as direct statements on or as an attachment to course syllabus Ms. Melanie Parker Ms. Parker reported that the SLO Committee may be recommending that SLOs start being attached to course syllabus that instructors distribute to students. They would additionally recommend that the Recommended Guidelines for Developing an Effective Syllabus be revised to include the SLO attachment. Discussion took place on whether it would be best to integrate the SLO into the COR; however, Ms. Parker feels the SLOs may be more flexible than the CORs and should be independent. Dr. Grishman stated that faculty may mix up the student evaluation portion with course outcome if the SLO is integrated onto the COR. Ms. Parker reported that Accreditation Standards do recommend that the SLOs be integrated with the syllabus, however, our recent Accreditation study report was very complimentary on our current process, using two separate documents. Ms. Lowry added that she feels eventually the Commission will dictate exactly how the SLOs are processed. Ms. Parker stated that the SLO Committee recommendations will go to the Senate as an informational item.
- 4. Mission Statement 2009-2010 College Catalog

Revisions to the AVC College Mission statement were prepared in 2007 based on Title 5 direction for inclusion to the next catalog. However, these revisions should have been presented to the Senate and Board of Trustees. The document was discussed with a few wording changes recommended. Mr. Mark Hoffer presented this recommended revision to ENGL 101. Dr. Grishman asked why a name change to a course that has been known as "Freshman Comp" for so long. Mr. Hoffer answered that due to the recent "Basic Skills" movement for students which is transforming college culture, there is a psychological component when students cannot take "freshman" composition in their freshman college year. A lengthy discussion took place with the committee asking to see what other colleges are doing. Ms. Drake asked if there will be a "technical composition" course added if this becomes "academic." Other discussion took place on whether this title would suggest that lower-level writing courses are "not" academic. Mr. Hoffer mentioned that there are other course names that could be considered. It was also brought up that to make a course name change mid catalog year would not be wise. A change to ENGL 101 should become effective with a fall term commensurate with the college catalog. Mr. Hoffer agreed and stated that the division also wants to rename ENGL 102 and 103. This revision request will be reconsidered and brought in at the same time as ENGL 102 and 103 revisions.

g. INT 205 – Interpreting in Specialized Settings 3 units, 5 hours weekly

Mr. Rumsey was asked to add the statement to the textbooks regarding old texts. This COR revision will come back to the next meeting.
