### 1.6 Approval of Financial Report.

Terrance Myers reviewed the ASO Profit and Loss budget from July 1 through October 5, 2012, where he highlighted ASO income, gross profit, total ASO expenses and their sub categories. Inquiries regarding the presentation of the net income were brought up and discussed to reflect a positive balance. Edward Oquendo moved to approve Terrance Myers to be solely responsibly when considering who goes to the National Center for Student

Leadership, seconded by Reiana Paul, Motion passed 8/0/1.

Homecoming - Reiana Paul reviewed the activities of Homecoming week for the days of October 15 - October 17, 2012 leaving days of October 18 and 19 open for ASO Camp Coming Home and the spaghetti dinner for the football players.

Sporting Events - Nancy Blundell asked for volunteers to sign up to work the football games on October 6, 2012 and the Homecoming game on October 20, 2012.

Leadership Workshop - Terrance announced the possibility of having the first workshop take place next Friday October 12, 2012 which is open to the public, however, due to no facility request present, the workshop may not take place and Dr. Zimmerman must be spoken to before confirming an established location, date and time.
