With AB 705, most colleges are providing support to aid students that are not required to take intermediate algebra. This course has been created to fall in line with what the rest of the state is doing. Comment by Isabelle Saber: It's important to have the conversation on the directions of corequisites being mandatory or others with the language of AB 705, forbidding it. James confirmed that it's been an ongoing discussion, but went ahead and put the course through, and he is aware that counselors will need to guide the students in this area. Isabelle brought up the concern of inequity of students who have to pay for the additional units, rather than offering the class as a non-credit class that would not be an additional cost. Students that are least prepared will have to pay extra to succeed in these classes. Non-credit would offer free support to help them do well.
